1. T-Mobile Northeast, LLC
236-248 Lindbergh Place; Block 6508, Lot 9
The applicant proposes to place twelve (12) panel antennas, eight (8) remote radio units and two (2) microwave dishes, together with equipment cabinets on the roof of an existing four-story building. The parcel has total area of 32,670 square feet. This proposal is located in the I-T Industrial Transition District of the Area 11 Redevelopment District.

2. JCM Investors 1012, LLC
77-91 Park Avenue; 4319, Lots 17, 18, 19 and 20
The applicant proposes to construct a four-story mixed use building with five (5) commercial spaces on the first floor and residential units on the second, third, and fourth floors. A total of forty-eight (48) residential units are proposed. Seven (7), one-bedroom units and nine (9), two-bedroom units are proposed on each of the upper floors. Forty-eight (48) parking spaces are proposed behind the first floor commercial spaces with access to Summer Street. A partial basement is also proposed with on-site laundry facilities and common tenant space. This proposal is within the C-1 Zone of the Fifth Ward Redevelopment Plan.
