250-252 Trenton Avenue (Block 7204, Lot 16.04, 16, 17, & 18)
Application to construct a two-family dwelling on a vacant lot.
(use, bulk, site plan) R-1 Zone
2. Art Asylum Tattoos (**CARRIED FROM 11/14/13**)
258 Grand Street (Block 5203, Lot 1)
Application to operate a tattoo parlor. Note Section 500-5.35G Tattoo, Body Piercing, and Skin Art Studio; not more than one studio at any time shall be approved to operate in the City of Paterson for every 75,000 residents of the City as published in the most recent census report issued by the U.S. Bureau of the Census.
