 20-21 Mill Street and 14-17, 19-21 Market Street

Block 4609, Lots 12, 13 & 14; Block 4609, Lot 11 & Block 4609, Lots 7, 8 & 9 The applicant proposes to remove the existing medical office space on the first and second floor of the building located at 19-21 Market Street and create 2 studio units, 12 one-bedroom units and 2 two-bedroom units within the existing first floor space and on the second floor create 13 one-bedroom units and 4 two-bedroom units within the existing second floor space. On the third and fourth floors, four of the existing one-bedroom units will be removed in order to create two-bedroom units, which will result in 13 one-bedroom units and 4 two-bedroom units on the third and fourth floors each. At 20-21 Mill Street, the applicant proposes to remove an existing office unit from the first floor commercial space and convert it to a three-bedroom unit that will be used as a building superintendent unit. This proposal is located within the Great Falls Historic District.
