Annually, the City of Paterson receives entitlement funds from the United States Department of Housing and Urban Development (HUD) for the Community Development Block Grant (CDBG), HOME Investment Partnership Program (HOME), Homeless Emergency Solution Grant (HESG) and Housing Opportunities for People with AIDS (HOPWA). In order to receive entitlement funds, HUD requires the City to submit an Annual Action Plan every year.

The 2019-2020 Annual Action Plan will begin on July 1, 2019 and will close on June 30, 2020, which must be submitted to HUD no later than May 15, 2019. The Plan will outline the intended usage of entitlement grants and required allocations. Grant application for CDBG, HOME, and HESG is available via the City's website ([www.patersonnj.gov/cd](http://www.patersonnj.gov/cd)) and can be picked up at the Department of Community Development, 125 Ellison Street, 2<sup>nd</sup> Floor, Paterson, NJ 07505. **Completed applications** must be submitted to the Department of Community Development no later than **Thursday, December 6, 2018 by 12:00 Noon**.
