1. JCM Investors 1012, LLC

185 & 187-189 Broadway; Block 3614, Lots 8 & 9

On the combined lots, the applicant proposes to construct a five-story mixed use building with one (1) commercial space and twenty-eight (28) parking spaces on the first floor with access to Broadway. The second, third, fourth and fifth floors propose ten (10) residential units per floor. A total of forty (40) residential units are proposed, consisting of twenty-four (24) one-bedroom units and sixteen (16) two-bedroom units. Variances are requested for side-yard setbacks, as a total of ten (10) feet is required and zero (0) feet is proposed; rear-yard setback, as twenty (20) feet is required and zero (0) feet is proposed; lot building coverage, as a maximum of 80 percent is permitted and 100 percent is proposed; and parking, as forty-one (41) parking spaces are required and twenty-eight (28) spaces are proposed. This proposal is within the C-2 General Commercial Zone of the Fourth Ward Redevelopment Plan.
