196 Rosa Parks Boulevard; Block 3501, Lot 15

The applicant proposes to demolish the existing structure on the site and construct a three-story mixed-use building on the 3,000 square foot parcel. One 1,250 square foot commercial space and seven residential units are proposed. The first floor proposes the commercial space and a one-bedroom unit. The second floor proposes 2 one-bedroom units and a two-bedroom unit. The third floor proposes 2 one-bedroom units and a two-bedroom unit. There will be a total of 5 one-bedroom units and 2 two-bedroom units. Variances are requested for rear-yard setback as a minimum of 20 feet is required and 16 feet 6 inches is proposed; lot building coverage, as a maximum of 80 percent is permitted and 84 percent is proposed; open space/amenity areas as 1,050 square feet is required and 480 square feet is proposed, and parking, one parking space is provided for the commercial use and two are required. A variance is also required for the first floor residential space as ground floor residential spaces are not permitted. This proposal is within the C-1 Neighborhood Commercial District of the Fourth Ward Redevelopment Plan.
