Partial Street Vacation of a Portion of Putnam Street

Location: Located at a point beginning 210 feet west of the Putnam Street and East 16<sup>th</sup> Street/York Avenue intersection and between lands now or formally owned by the New York Susquehanna & Western Railroad. Fifty (50) feet to a point in the southerly right-of-way line of Putnam Street, then 129.31 feet westerly to a point in the lands now or formerly of the New York Susquehanna and Western Railroad, then 50.12 feet to point in the northerly right-of-way line of Putnam Street, then 125.89 feet to a point easterly and place of beginning. Area to be vacated contains 6,384 square feet.

The applicant requests that the Planning Board recommend to the City Council the street vacation of a portion of Putnam Street as indicated above. The proposed vacated portion is an improved municipal roadway. The parcel in question contains approximately 6,384 square feet and is located south of Block 2805, Lot 1 and north of Block 2804, Lot 2.

Requires Recommendation to the Paterson City Council.
