## Servant's Heart Ministry 37-53 McBride Avenue; Block 4609, Lot 3

The applicant proposes to undertake an interior alteration, façade upgrades and an addition to the to the existing three-story building, also known as the Glenro Building. The first floor will house a vocational training commercial kitchen, programs in welding, woodworking and auto mechanics. The second floor will have an auditorium for performances and a dance studio for community performing arts classes. The third floor will have workspaces and an event area. A new rooftop addition will house a restaurant with indoor and outdoor seating area. A vegetable garden and solar panels will also be located on the roof. The lot contains approximately 25,668 square feet. This proposal is located within the MD-Medium Density Mixed-Use District of the Paterson Great Falls Redevelopment Area. Existing non-conforming conditions will continue for rear-yard setback, as a minimum of 20 feet is required and zero feet is existing and will continue at zero feet with the proposed building addition. A variance is required for parking, as zero off-street parking spaces are provided on-site and the applicant may provide off-site parking within one-thousand (1,000) feet of the subject property. The developer must demonstrate that daily/monthly permits are available in Paterson Parking Authority facilities or must enter into a shared parking agreement that satisfies the requirements.
