  - Notice to Quit
  - Notice to Cease
  - Notice of Termination
- Was your Section 8 terminated or denied?
- Were you evicted because you were told that your apartment was illegal?
- Did you have to leave your apartment because of a fire or flood?
- Did your landlord keep your security deposit?
