

**CITY OF PATERSON**  
**PUBLIC NOTICE OF EMERGENCY MEETING**

**BE ADVISED THAT THE MUNICIPAL COUNCIL OF THE CITY OF PATERSON HAS SCHEDULED AN EMERGENCY MEETING FOR THURSDAY, OCTOBER 4, 2012, AT 8:00 P.M. TO BE HELD IN THE COUNCIL CHAMBERS, THIRD FLOOR, 155 MARKET STREET, PATERSON, NEW JERSEY.**

The normal notice requirements of the Open Public Meetings Act have not been met. It is necessary to call this meeting pursuant to N.J.S.A. 10:4-9 because of an emergency situation that has developed. The nature of the urgency and importance is to prevent noncompliance with a directive of the New Jersey Division of Local Government Services to take certain steps in the City's Fiscal Year 2013 budget process no later than October 5, 2012. Such noncompliance with the State's statutory authority in municipal budget matters would subject the City to potential sanctions and penalties and jeopardize the City's eligibility for State Fiscal Year 2013 budgetary financial assistance. Such consequences would result in substantial harm to the public interest by jeopardizing the City's ability to ensure continuation of vital services necessary to maintain the public safety, health and welfare of its residents.

If a meeting of the Municipal Council had been delayed in order to give proper notice under the Open Public Meetings Act, substantial harm to the public interest would have resulted if these matters were not considered by the Municipal Council.

This meeting was called on Tuesday, October 2, 2012 and on that day, notice of this meeting was given by posting the notice at City Hall, 155 Market Street, Paterson, New Jersey, by filing it with the City Clerk, and by sending the notice to the North Jersey Herald News, The Record, The Arabic Voice, The Italian Voice, The New Passaic County Pulse, The New Jersey Pulse (formerly known as The Paterson Pulse), The Rumbo Latino, The Quisqueya International, The El Especial, The Christian Heritage and the Paterson Press newspapers as required by N.J.S.A. 10-4-9.b.(3).
